Theme 1: The spillover effect of public values dynamics: Reforming institutions

Theme 2: The impact of the public action on the outcomes measurement and assessment of service delivery structures: the case of participative, collaborative and partnership approaches

Theme 3: The impact of new public management inspiration-based reforms on government executives: public leaders challenged by accountability

Theme 4: The impact of tools and instruments of public management: between structuring and uncontrolled hybridization.

Publication

The texts resulting from the best papers presented at the Symposium and ADIMAP 2018 will be proposed to the International Management (IM) journal and one or more other scholarly journals operating on an international scale, for possible publication in one or more thematic files.

TARGET AUDIENCE

Promoting a culture of exchange and debate among academics, practitioners and public affairs consultants, as well as the transfer of scientifically developed knowledge to organizations of the common good, the public interest and the public service, are particularly targeted by the organizers of the Symposium/main purpose of the Symposium.

Therefore, the speakers and panelists selected for the Symposium 2020 Edition will address public leaders, senior government officials, managers and public administration professionals, doctoral students and research scientists, policy makers and/or public management figures at the French-speaking countries.


All contributions will be assessed using a double-bind review process which means the identities of the authors are concealed from the reviewers, and vice versa.
